Police Report - placed on file

Mark Crosson presented an overview of the revised Police Reform Report that he spent many hours on. This is due to NYS Governor's office by April 1. Report may be viewed at per request. (delete "at") Mark has also been busy updated the Standard Operating Procedure (SPO) which was very outdated. Shawn Recktenwald reported the police budget will need to be modified in order to keep up with the mandated training, etc.

DPW Report -

John Krist stated that the DPW have been plowing and salting. The salt truck was disassembled and cleaned for season. The Flood Gates where shut due to high water levels have to manual be turned on and off. Dehumidifying fans where installed at the well house to help with moisture. There was a leak in the dyke Village Engineer was consulted with best course of action for repairs. John Krist, Josh Hall, and Tim Krzos are all taking a Water certification course this week at JCC in Olean.

DPW has been busy at the Sewer Treatment Plant (STP) attempting to repair and fix areas in need. John has been going to the STP every 4hours to turn certain pumps on/off until he is able to repair and automate them. Cattaraugus County Health Dept (HD)met with John regarding the North Well Reservoir and the severe moisture issues, which will cause premature rotting of the facility. John will be installing fans to help with the excessive moisture and the HD agreed. There was a 6" water main leak on Temple Street under the dike and the more that was dug, the more the water leaked. DEC required that Village Engineer, Jim Hannon, to be called in and it was recommended that two valves be installed for now, stopping the leak and the middle portion of the water pipe that crosses Dodge Crrek

was cut off for now. It is a requirement that the UV system at the STP be installed from March 15 - Oct 15. New ballasts and flow meters are needed in order for this system to work. John called around for the best prices and the lowest was price for the ballista was \$7,600, which the Board approved. DPW has also been busy cleaning the shop, organizing and replacing water meters. John stated they will need safety gear and training in order for Confined Space Entry, he has sent out the meters to be recalibrated by EJP, which is mandated to use prior to going into a confined space.

Mayors Report – Mayor Tony Evans reported that from now on only the Police and Justice reports will be placed on file due to privacy issues. All other departments will be included in the monthly meeting notes so residents can view what has been occurring. Tony inquired if the Pioneer Park Rental Agreement has been finalized. Vince and Kristen worked on this and both stated it was. Discussion took place if this should be placed on the Village website for residents to view. Discussion also included whether to include an on-line availability calendar. Cost is \$150 to rent.

Tony reported that a \$390,000 stimulus was reported in the Olean Times Herald that will be divided between the Town and Village, but amounts are yet to be announced. Tony spoke with Cindy Wagner, Olean Times Herald who is working on an article regarding community progress. Cattaragus County will be passing a shared agreement next week, which includes the Village.

Tony encouraged John/DPW supervisor to schedule DPW workers for Tetanus & Hepatitis vaccines with the Cattaraugus County Health Dept to help protect them while dealing with raw sewage, etc.

Village elections are tomorrow from 12-9 p.m. Joe McLarney & Mike DeBarbieri are running unopposed for the board trustee positions. Judy McClain is running unopposed for Village Judge, as Judge Chris Piaggi has decided not to run another term and will be retiring effective 3/31. The Board thanked Judge Piaggi for his many years of service and a card thanking him will be mailed to him.

Tony read the Portville Public Worker Pandemic Plan which describes how our workers will be protected during a pandemic. The Board approved the plan.

Matt Zarbo of Barton & Loguidice is waiting on grant information. We must wait a certain time. An independent financial advisor is required so

we hired Fiscal Advisors & Marketing of Leroy, NY. We were also required to hire an attorney, Tim McGill of Rochester, NY. There was no discussion and all board members approved.

Was reported that the Village is to receive a stimulus the Board is unsure of the amount we will be receiving at this time. Mayor Evans has been speaking to Olean Times Herald regarding an article on Community Progress. Signed a County shared service agreement

Old & New Business:

Bob Fischer would like to have the Pine Street Cemetery surveyed but since there is no deed, the surveyor can't complete the survey unless they receive permission from neighbors whose property borders the cemetery. Bob would like to have the corner markers marked, which will cost about \$500. Money remains in the Eschelman account to care for the cemetery. Bob also showed a map showing various stones/graves that were previously located.

- 2.) Implicit Bias Training. The Village shall employ and properly train 011 current and newly hired police officers in implicit bias and trauma involved care. This will provide for officers to have a better understanding of victims and suspects and how to properly assist them.
- 3.) Implicit Bias In-Service Training. The Portville Police Department shall certify their police instructors in implicit bias train the trainer certifications. The Portville Police Department instructors will provide implicit bias in-service refresher training on a yearly basis to all employees.
- 4.) Outreach. The Portville Police Department will continue to schedule outreach events yearly in an effort to bring the police department and the community together to help build trust,
