1. Permits may be issued by Building Inspector without Planning Board approval if construction is residential and not a change of use .
 2. Permit fees may be doubled at the discretion of the Building Inspector if construction begins before the permit is issued, or if additional legal notices are required
 3. Applications must conform to NYS Building Codes, all local ordinances, and the Town of Portville Comprehensive Plan
 4. Variance applications must be submitted to the Planning Board. Proposed variances may require a public hearing and require Town Board review for consideration of approval
 5. Payment for permit must be by personal check, cashier's check or money order. Building Inspector is not allowed to accept cash under any circumstances.
- Returned checks will have a \$35 returned check charge and the issued permit and Certificate of Occupancy will be revoked.

Commercial New Building \$.20 per *sf* plus \$25 each plumbing unit

Residential New Building \$.15 per *sf* plus \$25 each plumbing unit

Floor area shall be based on outside dimensions of the structure including an accessory garage but not to include a non-habitable basement, non-habitable attic or carport
